## SECTION 4 – FIRST AID MEASURES

## SECTION 7 – HANDLING AND STORAGE

<b>Handling</b>	Avoid skin or eye contact with concentrate. Wear protective clothing when risk of exposure occurs. Avoid contact with incompatible materials.
